MAXIMUM ALLOWABLE GROSS WEIGHT SHIPMENTS ON THE KANSAS CITY SOUTHERN RAILWAY COMPANY

KCS' system is in most places approved to handle up to 143 tons gross weight on rail (GWOR), however, in several locations the track structure is not capable of adequately handling and distributing 143 tons GWOR. To eliminate damage to rail infrastructure that can occur from the shipments of rail cars that exceed the maximum GWOR, KCS is publishing restrictions on its line to commit to the safe, damage free delivery of our customer's shipments.

Customers shipping on KCS should review the following pages for KCS lines with weight restrictions. Cars shall not exceed the weight restrictions listed.

For weight restrictions on lines: The Alabama Southern Railroad (ABS), The Arkansas Southern Railroad (ARS), The Louisiana Southern Railroad (LAS), The Mississippi Southern Railroad (MSR), and the Vicksburg Southern Railroad (VSOR) operated by Watco Company please visit their website at <http://www.watcocompanies.com/railroads.htm>.

Weight restrictions on the Meridian Southern Railway LLC between Waynesboro, MS and Meridian, MS is a maximum GWOR of 263,000 lbs or 131.5 tons.

WEIGHT LIMITATIONS:

The following will govern gross weights (combined weights of cars and lading) allowed on the KCS Railway:

1. Unless otherwise restricted in 2. below, the maximum GWOR authorized load limits on KCS' system is 143 tons.
