LSARs become exercisable only following a change-in-control of the Company in lieu of related options and are exercisable only for cash. LSARs terminate when the related options are exercised or terminated.
- (3) - These options became exercisable in installments: 25% on June 23, 2001, 25% on June 23, 2002 and 50% on June 23, 2003.
- (4) - These options became exercisable in installments: 2,206 on February 6, 2002, 1,102 on June 23, 2002 and 2,205 on June 23, 2003.
- (5) - These options became exercisable in installments: 4,139 on January 16, 2003 and 2,758 on June 23, 2003.
